On behalf of the Hon'ble Governor of Sikkim, the Tourism & Civil Aviation Department, Government of Sikkim invites Pre-Qualification bids from Contractors having valid enlistment with the Sikkim Public Works Department (SPWD), Government of Sikkim as Class I-AA for execution of the project **"Conversion of Singshore Bridge as a glass skywalk bridge for tourist attraction under Gyalshing District, Sikkim (Turnkey)"** in Engineering-Procurement-Construction (EPC) mode. The interested Contractors shall submit their Pre-Qualification Bid to the Principal Chief Engineer, Tourism & Civil Aviation Department, Paryatan Bhawan, Tadong, Gangtok District, Sikkim on or before 16/01/2024 along with the requisite documents to fulfil the Pre-Qualification bid as per the eligibility criteria detailed in Expression of Interest uploaded in the official website of Tourism & Civil Aviation Department i.e. [www.sikkimtourism.gov.in](http://www.sikkimtourism.gov.in). 2	The intending bidder shall have adequate experience in construction of civil works fulfilling at least one of the following criteria: - <b>a.</b> Three ongoing/completed projects costing not less than ₹ 19.20 Crore each. <b>b.</b> Two ongoing/completed projects costing not less than ₹ 24.00 Crore each. <b>c.</b> One ongoing/completed project costing not less than ₹ 38.40 Crore.	Certificates issued by the concerned authority of Government not below the rank of Superintending Engineer along with his/her name, contact number and e-mail address for verification.
3	Average Annual Financial Turnover of the intending bidder shall be at least ₹ 14.40 Crore during the last three years ending 31st March of the previous financial year.	Certificate duly Vetted by registered Chartered Accountant.
4	Intending bidder shall submit Profit/Loss account statement, should be as on 31st March of the previous financial year.	Certificate duly Vetted by registered Chartered Accountant.
5	Solvency Certificate shall be produced for an amount equal to ₹ 19.20 Crore.	Solvency Certificate issued from State Bank of Sikkim or of any other Nationalized Banks operating in Sikkim.
6	GST Registration	Certified copy to be enclosed.
